State Structure

In Connecticut, administration of delinquency services is split between the executive and judicial branches. The judicial branch, Court Support Services Division (CSSD) administers probation in 12 court locations. The CSSD also operates the two secure detention facilities. The Department of Children and Families (DCF), a state-level executive agency, administers aftercare services and commitment to public state facilities.

Status Offenses

In Connecticut, running away from home, being beyond the control of parents or guardians, being a truant, having more than a specified number of absences from school in a month (4) or school year (10), or engaging in sexual intercourse with another person 13 years of age or older and not more than 2 years older or younger than the child are status offense behaviors.
